This Memorandum of Understanding is approved on Friday, February 14th 2025, in Yogyakarta, in the English language, both being equally authentic.

Sunan Kalijaga State Islamic University Yogyakarta, an institution of higher education under the Ministry of Religious Affairs, was established in 1951, having its address at Jl. Marsda Adisucipto No.1 Yogyakarta, Indonesia, 55281, represented by Noorhaidi, in this matter acting in his capacity as Rector of Sunan Kalijaga State Islamic University, Yogyakarta, hereinafter referred to as the "First-party"

AND

Hartford International University for Religion and Peace, (formerly Hartford Seminary) is a private theological University in Hartford, Connecticut, founded in 1834, having its address at 77 Sherman Street, Hartford, Connecticut, United States of America, represented by David D. Grafton in this matter acting on behalf of the President of Hartford International University for Religion and Peace, hereinafter referred to as the "Second party"

Both of them hereinafter referred to as "the Parties";

consider their common interests will be promoted through mutual cooperation in the form of academic collaboration;

The Parties intend to partner with the shared goal of developing collaborative educational programs within both institutions,

HAVE AGREED AS FOLLOWS:

ARTICLE I

OBJECTIVES

This cooperation aims to explore and develop collaborative educational initiatives aligned with the strategic objectives of both institutions, thereby strengthening and enhancing their respective goals

ARTICLE II

SCOPE OF ACTIVITIES

The scope of activities of the cooperation may include but shall not be limited; to participation in seminars, study tours, professor and student exchanges, professional development and training programs, research projects and community service programs, within the provision of available funding of both Parties; and any other co-operation that will mutually identify and agreed upon by both Parties at later stages

ARTICLE III

MEMORANDUM OF AGREEMENT/IMPLEMENTATION AGREEMENT

A detailed description of the scope of activities shall be defined in a Memorandum of Agreement or Implementation Agreement for agreed-upon programs, which is set out in the annex and shall constitute an integral part of this Memorandum of Understanding.

ARTICLE IV

OBLIGATIONS

For mutually agreed upon programs and projects, the obligations of Sunan Kalijaga State Islamic University and Hartford International University will be agreed upon and put in writing as part of a Memorandum of Agreement/Implementation Agreement for the respective programs and projects.

ARTICLE V

NON-BINDING

The Parties agree that this Memorandum of Understanding only expresses the intention of the Parties, is not binding and does not create any legally enforceable obligations between the Parties.

ARTICLE VI

SETTLEMENT OF DISPUTES

Any dispute concerning the interpretations of this Memorandum of Understanding shall be settled amicably through mutual consultation and negotiation.

ARTICLE VIII

AMENDMENT

This MoU can be reviewed or amended at any time by mutual written consent of the Parties. Such revisions or amendments shall enter into force on such date as may be determined by the Parties and shall form an integral part of this MoU.

ARTICLE IX

ENTRY INTO FORCE, DURATION AND TERMINATION

- 1. This Memorandum of Understanding shall enter into force on the date of its signing.
- 2. This Memorandum of Understanding shall be valid for the period of 5 (five) years and will be automatically renewed on an annual basis thereafter unless either Party notifies in writing of its intention to terminate this Memorandum of Understanding 6 (six) months prior to the expiration of this Memorandum of Understanding.
- This Memorandum of Understanding may be terminated when either Party notifies in writing of its intention to terminate this Memorandum of Understanding, providing 6 (six) months advance notice.
- 4. The termination of this Memorandum of Understanding shall not affect the validity and duration of any ongoing programs or activities as agreed upon in the Memorandum of Agreement.
