



MEMORANDUM of UNDERSTANDING

Between

**Prof. Dr. Fuat Sezgin Research Foundation for the History of Science in
Islam (Türkiye)
and
Universitas Islam Negeri Sunan Kalijaga Yogyakarta (Indonesia)**

This Memorandum of Understanding is made on this (20 day of December in the year 2022), in Yogyakarta, in the English language, both being equally authentic.

Prof. Dr. Fuat Sezgin Research Foundation for the History of Science in Islam an institution of under the Ministry of Culture and Tourism - Directorate General of Foundations which was established in 2010, having its address at İslam Bilim Tarihi Araştırmaları Vakfı, Gülhane Parkı İçİ , Sirkeci-Fatih 34112 İstanbul, represented by **Mecit ÇETİNKAYA**, in this matter acting in his capacity as the President of the Board of Directors of Prof. Dr. Fuat Sezgin Research Foundation for the History of Science in Islam, and validly acting for and on behalf of Prof. Dr. Fuat Sezgin Research Foundation for the History of Science in Islam hereinafter referred to as the **"First party"**.

AND

UIN Sunan Kalijaga Yogyakarta (UIN SUKA), an institution of higher education under the Ministry of Religious Affairs which was established in 1951, having its address at Jl. Marsda Adisucipto No.1 Yogyakarta, Indonesia, 55281, represented by **Al Makin**, in this matter acting in his capacity as Rector of UIN Sunan Kalijaga Yogyakarta, and validly acting for and on behalf of UIN Sunan Kalijaga Yogyakarta, hereinafter referred to as the

"Second party"

Both of them hereinafter referred to as "the Parties".

The Parties are interested to engage in cooperative educational and research activities, for the mutual benefit of both institutions, the parties have agreed upon the following:

- I. The parties will jointly develop cooperative educational and research programs to introduce Prof. Dr. Fuat Sezgin and to support his studies on the History of Science within the framework of this agreement. The cooperative activities to be covered by this agreement may include exchanges, study abroad, collaborative research programs, seminars and workshops, and service programs.
- II. Each activity to be performed under this agreement will be undertaken pursuant to an addendum that will contain the specific terms and conditions governing the activity. These terms and conditions will be mutually agreed upon by the two institutions on a case-by-case basis.
- III. Each institution will be responsible for seeking funds to support its involvement in the cooperative activities contemplated under this agreement, and all such activities will be dependent upon the budgetary appropriations of the parties.
- IV. All activities developed hereunder will be in accordance with all applicable rules and regulations of the home and host institutions, and all applicable federal, state and local laws, rules and regulations.
- V. UIN Sunan Kalijaga Yogyakarta appoints Vice Rector of Student and Cooperation Affairs and the Prof. Dr. Fuat Sezgin Research Foundation for the History of Science in Islam appoints Vice President of the Board of Directors to coordinate the development and implementation of this agreement.

VI. This agreement will be in effect for a period of five (5) years from the date of execution and may be renewed for additional five (5) year periods by the parties. Either party giving ninety days written notice to the other party may terminate the agreement provided that such termination will not affect the completion of any activity underway at the time or any previously advertised activity in which commitments to University students have been made.

VII. Any communication under this Memorandum of Understanding shall be in writing in the English language and delivered by registered mail to the address or sent to the electronic mail address or facsimile number of Prof. Dr. Fuat Sezgin Research Foundation for the History of Science in Islam or UIN Sunan Kalijaga Yogyakarta, as the case may be, shown below or to such other address or electronic mail address or facsimile number as either Party may have notified the other Party and shall, unless otherwise provided herein, be deemed to be duly given or made when delivered to the recipient at such address or electronic mail address or facsimile number which is duly acknowledged:

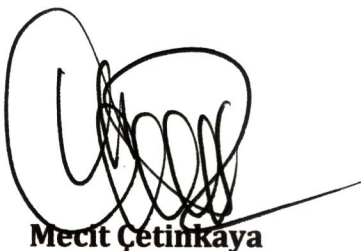
