

**AGREEMENT ON ACADEMIC EXCHANGE
BETWEEN
GRADUATE SCHOOL OF HUMANITIES /SCHOOL OF FOREIGN STUDIES
THE UNIVERSITY OF OSAKA
AND
GRADUATE SCHOOL/ SCHOOL OF SHARIA AND LAW
SUNAN KALIJAGA STATE ISLAMIC UNIVERSITY OF YOGYAKARTA**

The Dean of the Graduate School of Humanities /School of Foreign Studies, The University of Osaka, Japan and the Dean of the Graduate School /School of Sharia and Law, Sunan Kalijaga State Islamic University of Yogyakarta, Indonesia, with the objective of promoting cooperation in the fields of education and academic research, agree to conclude the following agreement on academic exchange.

Article 1

Both institutions agree to promote the following activities to enhance their education and academic research:

- (1) Activities such as collaborative research, lectures, symposiums, etc., and the exchange of researchers pertaining thereto;
- (2) the exchange of information and materials in those fields, which are of interest to both institutions;
- (3) and the exchange of undergraduate and graduate students.

Article 2

Specific matters pertaining to the implementation of the exchanges between both institutions shall be negotiated and agreed upon between the parties concerned in each specific case and may be stipulated in writing.

Article 3

The applicable law of this agreement shall be the laws of Indonesia when the cooperation is carried out at Sunan Kalijaga State Islamic University of Yogyakarta, and the laws of Japan when carried out at The University of Osaka.

Article 4

Both institutions agree to adhere to and comply with applicable export control laws and regulations. Both institutions agree that this academic exchange does not aim for design or development of military equipment, including but not limited to weapons of mass destruction. Weapons of mass destruction are defined as nuclear, chemical, biological weapons and missiles, and other unmanned aerial vehicles for military use.

Article 5

This agreement shall become effective on the date of its signing by the representatives of both institutions and shall be in force for five (5) years.

Article 6

This agreement is subject to revisions by mutual written consent.

Article 7

Either institution may, by giving six (6) months' written notice to the other institution, terminate this agreement. However, termination of this agreement shall not affect the implementation of the collaborative activities established under it prior to such termination.

Article 8

In the absence of any such early termination, the renewal of this agreement shall be discussed by both institutions at least six (6) months prior to the natural termination of the current agreement.

Article 9

This agreement is to be executed in English and each institution shall retain an original copy.
